After the meeting, he created a Task Force that was charged with formulating recommendations for the revitalization of the Bar's Member Assistance Program with the intent to expand the services offered to lawyers and judges struggling with substance abuse, addiction, mental health challenges, and stress. I was appointed as one of seven attorney members of the Task Force (two judges were also appointed). The Task Force's recommendations were approved by the Arizona Board of Governors and on January 8, 2021 the Task Force's recommendations were presented by the Arizona State Bar in a petition to the Arizona Supreme Court for approval.
