As the country emerges from COVID-19, the Biden administration's EEOC is beginning to flex its muscle. EEOC investigators are increasingly demanding documents and conducting on-site

investigations and interviews of employees. Even in the mediation process, the EEOC is insisting on a "measure of accountability" by employers before resolving claims.
