### Convention Cancellation Policy

A refund of registration fees less \$85 and any applicable credit card fees will be given if the FDCC office receives written notice no later than February 2, 2022.

No refunds will be given if notice of cancellation is received by the FDCC office after February 2, 2022.

In the event of special circumstances such as illness or unforeseen family or professional emergencies, this refund policy may be suspended or modified (based upon the member's written request) only by action of the president upon recommendation of the Convention Chair. It is highly recommended that all registrants get trip cancellation insurance.

Please notify the FDCC office by email ([martha@thefederation.org](mailto:martha@thefederation.org)) once you have cancelled your hotel reservations. Neither the Convention Chair nor the FDCC office has authority to modify the hotel's cancellation policy.

Charges paid to the FDCC for separate events/activities may or may not be refunded in whole or in part. The decision to refund these will be made on a case-by-case basis by the Convention Chair. Members seeking reimbursement for these payments must submit a written request to the Convention Chair.

The decision to refund fees will be based, in part, on the timing of the cancellation and whether there are available convention funds from which to make the refund. Please note that refunds of any payments to independent third parties for tours and other events and services are not the responsibility of the FDCC.
