Keynote speakers will include David McRaney, author of *How Minds Change*, who will offer techniques for effective persuasion in an increasingly polarizing environment, Justice Elizabeth Walker from the West Virginia Supreme Court, and 2024 ESPN Sports Personality of the Year, Holly Rowe. We will explore the dangers and legal ramifications of deep fakes, train to use cutting-edge technology in trial, navigate the hours, days and weeks immediately following a verdict or crisis, and study the impact of recent Supreme Court decisions on our civil defense practice. Our program will offer you a boot camp of training opportunities with champions from inside and outside the FDCC on cutting edge techniques, legal developments and advocacy.

Afternoons are yours to explore and enjoy the beauty and majesty of the Wasatch Mountains and historic Park City. For the adventurers, you can choose from white water rafting, a day at Olympic Park, an E-Bike mountain tour, ATV’s in the mountains, hiking,

And, it will again serve as a hub for competition in the 2034 Winter Olympics, which are returning to Park City. We will have the run of the Olympic Winter Games Museum, following by a gourmet meal and exciting dinner show unlike anything in the FDCC's history. This event will be one to remember!

Our last night will be casual, family-friendly, and fun at the Lodge. Think of a backyard party, music and smores in the most beautiful mountain setting you can imagine with your Federation family. No need to dress up, no extra shopping or packing necessary for this low-key night before we all have to return to the hustle and bustle of our daily lives.

Movie Theater

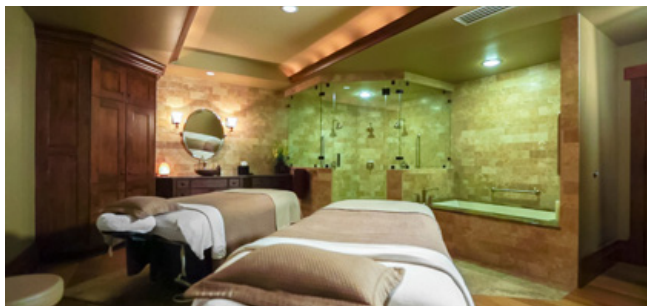

GETTING THERE

Stein Eriksen and the Chateaux are approximately 45 minutes from Salt Lake City International Airport. Transportation and shuttle services between the airport and Park City are plentiful, along with Uber, Lyft and Taxi services. Feel free to contact the hotels' preferred vendor, Snow Country (435-645-6460) to make reservations prior to your arrival.

Main Street is wonderfully walkable and also offers a free transit system. The free shuttle from Stein Eriksen and Chateaux will take you to and from Main Street and other Deer Valley resort spots. No need to rent a car or hassle with parking. Please be aware that the legal limit for blood alcohol while driving in Utah is .05, well below that of the rest of the nation

Weather

With average high temperatures below 80°F and nighttime temperatures in the mid-50's, Park City is the place to be in the summer. The probability of rain is low, as is the humidity, and the likelihood of clear skies and fresh mountain air is very high!

Elevation

Park City is situated about 7,000 feet above sea level. This makes for glorious vistas and clean mountain air but may take some preparation and acclimation. Stein Eriksen and the Chateaux are 8,200 feet above sea level. Besides giving your body time to adjust to the new altitude when you arrive, consider:

Drink 4-6 liters of water per day to stay hydrated.

Eat high carbohydrate foods

Cut down or avoid alcohol

Cut down or avoid smoking

Pace yourself for the first 24 hours and avoid strenuous activities.

Child Care

The FDCC will have special, age-appropriate programming for teens and children during the adults-only Presidential Reception on Monday night and Wednesday during the Dine-Arounds. **Pre-registration is required.** Children must be at least 3 years old and fully potty trained to participate.

Teens and children are welcome to attend all other scheduled events.

If you desire childcare at any other time during the convention, Stein Eriksen partners exclusively with [PARK CITY SITTERS - Parkcitysitters/home](https://www.parkcitysitters.com) to offer on site, professional child care services. Hourly rates start at \$50 per hour per child with a 4-hour minimum. Contact the Concierge for reservations and more information (435-645-6460). Please note, however, that the FDCC does not endorse the hotel's childcare services or make any representations about their quality standards or fitness. Please use at your own risk.

Solos

If you are attending "solo", let us know! The registration form will include an opportunity to indicate if you would like to be part of any "solo" plans, including the FDCC Dine Around night. Once onsite, we will have opportunities for you to get together with other solo attendees – whether this is your first meeting or your 10th!

What to Wear/Dress Code

Overall, the dress code for summer in Park City is relaxed and comfortable. Feel free to pack casual clothes for your afternoon excursions and dine-around evenings and plenty of activewear for hiking, biking or exploring. Once the sun goes down, things cool off, so bring a light jacket or sweater with you just in case!

For meetings and education sessions, we recommend business casual attire. Recommended attire for the evening events and specific activities is identified with each event, but you will want to make sure to pack cocktail attire (and a wrap to keep you warm in the cool night air) for the President's Reception. Otherwise, be comfortable and ready for fun!

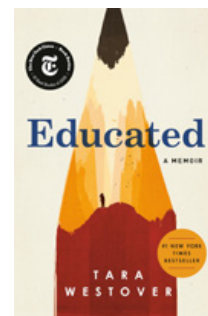


The charm for the 2025 Annual Meeting in Park City, Utah is the snowflake. Utah is home to the Greatest Snow on Earth. Because of the lake effect of the Great Salt Lake, much of the snow that hits the mountains of the Wasatch front is lighter, drier, and powdering. Utah's "champagne powder" makes its 10 ski resorts within one hour of Salt Lake City a premier destination for winter sports fanatics and a fabulous host for the Olympics.

Book Club

Educated is a memoir by Tara Westover that chronicles her extraordinary journey from growing up in a strict, survivalist Mormon family in rural Idaho to earning a PhD from Cambridge University. Raised in the isolated mountains near Clifton, Idaho, Westover's upbringing was deeply influenced by her family's fundamentalist beliefs and mistrust of government institutions. Westover's father prohibited his children from attending school or seeking modern medical care, instead insisting that they work in his junkyard and rely on their mother's herbal remedies. Without birth certificates, immunizations, or formal education, Westover and her siblings lived largely outside mainstream society. Despite these limitations, Westover's desire for knowledge led her to self-educate and find mentors who encouraged her to continue her education. Westover's memoir is a compelling narrative about the cost of knowledge and self-reinvention, while raising questions about the role of religion, family, and personal agency.



REGISTRATION

The early bird conference registration rate is \$1,995 for Defense Counsel members and \$850 for spouses, significant others and immediate adult family members. The early bird registration ends on June 15, 2025. After that date, the rate is \$2,145 for Defense Counsel members.

For Corporate and Industry members, their spouses, significant others and adult family members, the rate is \$850.

The rate for Emeritus Members and their guests is \$850

The registration rates for children are tiered based upon age. Children 3 and under are complimentary. Children 4 to 11 are \$260, children 12 – 17 are \$425, and children 18-20 are \$650.

Once registered, you will receive a link that will allow you to reserve a room in our discounted room block. **Rooms are limited, and the block will fill up quickly, so please make your room reservations promptly.** You cannot book a room until after you have registered for the convention. A first night's room and tax deposit is required at the time of booking. Our room block and the preferred FDCC room rates are available until July 2, 2025 or until we fill our block.

CANCELLATION POLICIES

Hotel Cancellations

All reservations are guaranteed with a deposit of the first night's reservation fee. Hotel cancellations received less than 14 days before arrival will forfeit the one-night deposit. The FDCC has no authority to modify the hotel's cancellation and refund policies.

Convention Registration Cancellation Deadline

A refund, less any applicable credit card fees, will be given if the Executive Director receives written notice no later than June 28, 2025. A refund of all registration fees, less \$250, will be made if the notice of cancellation is received by the Executive Director on or after June 28, 2025, but before July 18, 2025. A refund of all registration fees, less \$500, will be made if notice of cancellation is received by the Executive Director on or after July 18, 2025. 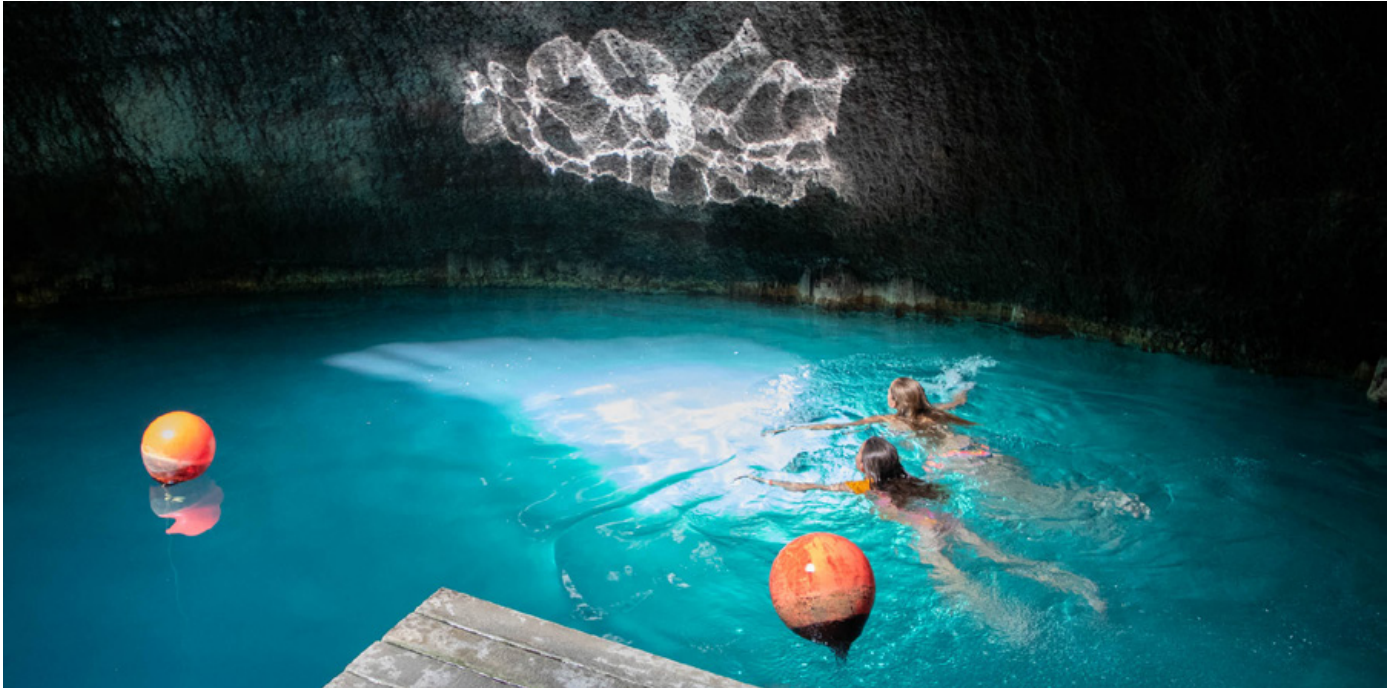

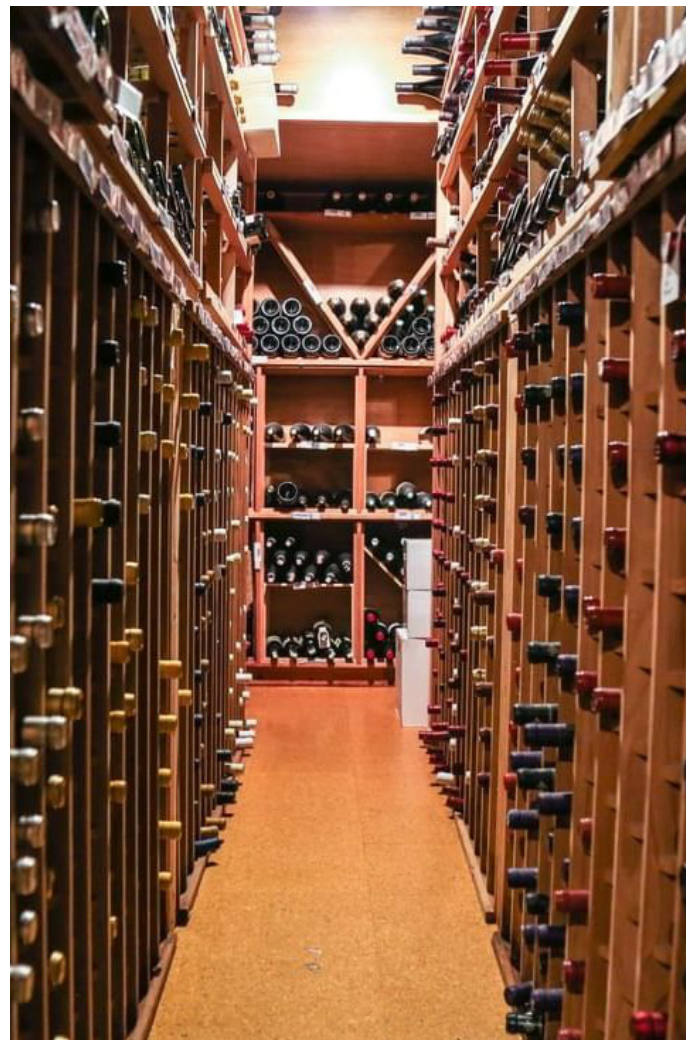
