Convention Cancellation Policy:

A refund, less any applicable credit card fees, will be given if the FDCC Executive Director receives written notice no later than **June 28, 2025.**

A full refund of all registration fees, less \$250, will be made if the notice of cancellation is received by the Executive Director on or after June 28, 2025 but before July 18, 2025.

A refund of all registration fees less \$500 will be made if the notice of cancellation is received by the Executive Director on or after July 18, 2025.

Activity charges may be refunded if the Vendor refunds fees or if another member fills and pays for the spot vacated by the cancellation. Any refunded activity fees will be settled following the conclusion of the meeting.
