filled with good memories. Charleston has an almost indescribable charm, and we have tried to create a meeting that will give you lasting memories of being in a beautiful place with your friends and family.

The brochure that follows contains all the details about the amazing things we have planned for your stay, but allow me to highlight a few of them here:

Our evening events are designed to let you relax and mingle with old FDCC friends and make new acquaintances. Our opening reception will be at the Riviera Theater, a beautifully restored art deco theater just across the street from the hotel, where guests can enjoy a pre-dinner cocktail in a festive and elegant setting. The President's Reception will be at the South Carolina Aquarium, a short ride from the hotel and overlooking the waterfront. With views of the Ravenel Bridge outside, and a host of aquatic exhibits inside, the Aquarium will provide a unique and fun setting as we dine and enjoy each other's company. The final night party features a 10-piece band for those who want to dance the evening away, and cozy lounge areas and craft cocktails (or mocktails) for those who prefer to visit and watch all the action in laid back style.

The program is truly outstanding, and includes many notable judges, legal scholars, and practitioners, as you would expect from an FDCC event. # Registration



The early bird conference registration rate is \$1,995 for Defense Counsel members and \$850 for guests. Early bird registration ends on January 13, 2025. After that date, the rate is \$2,145 for Defense Counsel members and \$850 for guests.

The rate for Corporate and Industry members is \$850.

The rate for Emeritus Members and their guests is \$850.

The registration rates for children are tiered based upon age. Children 3 and under are complimentary. Children 4 to 11 are \$260, children 12 – 17 are \$425, and children 18-20 are \$650.

Built in 1986, The Charleston Place was designed to complement Charleston's historic architecture in the heart of the downtown community. Together with its restaurants, cocktail lounge, spa, and retail shops, The Charleston Place quickly won the hearts of locals, vacationers, corporate travelers, meeting planners, and wedding planners alike. Since FDCC's last visit to The Charleston Place in 2017, it has been bought by a local hospitality group and has been updated and refurbished. In fact, the meeting rooms were completely renovated this year, and FDCC will be among the first groups to use the updated facilities.

Our room block consists of 270 of the hotel's 433 rooms. For a deluxe "run of house" room, we have negotiated a rate of \$375 per night, plus taxes and resort fees. (As of this writing, deluxe rooms at The Charleston Place are offered to those outside our group at \$595 per night, plus tax.)

After you register, you will receive a link with which you can reserve a room in our room block. **You must register for the Winter Meeting before you can book a room within our room block.**

Our room block is guaranteed until January 22, 2025, or until all 270 rooms are booked.

The Charleston Place has a valet parking service for \$56/day. For non-valet parking, a City of Charleston parking garage is located adjacent to the hotel, accessible from the hotel's Meeting and Hasell Street entrances.

The hotel's Thoroughbred Club lobby bar is open Sunday – Thursday until 11:00 pm, and Friday – Saturday until 12:00 am, while the more casual Meeting at Market pub is open every night until 11:00 pm.

## Getting to Charleston and The Charleston Place Hotel

Charleston International Airport is served by all major U.S. air carriers, with dozens of direct flights, so travel to Charleston should be easy and convenient.

From the airport, it's an easy 25 minute car ride to The Charleston Place, and taxis and Uber/Lyft are readily available, as is a convenient car rental facility.

## Dress Code and Weather

Charleston generally enjoys temperate weather, and in late February, you can expect temperatures with lows in the 50s to highs in the 70s. Many of our afternoon activities are on the water, or otherwise outdoors, so please pack appropriate clothing and a rain jacket if you plan to be outside.

For the program and business meetings, we recommend business casual attire. Most of the area restaurants have a casual dress code.

The Welcome Reception and final evening band party are cocktail attire. The President's Reception is business casual.

# General Information

## Charm

The FDCC started selecting gold charms to commemorate its meetings in 1960. ## **Students/Social Media and The First Amendment After *Mahanoy* Area School Dist. v. B.L.**

It has been 55 years since the Supreme Court announced that students do not "shed their constitutional rights to freedom of speech or expression at the schoolhouse gate." With the advent of social media, the schoolhouse

gate no longer provides a physical boundary to distinguish a student's citizen speech from more restrictive school speech. In *Mahanoy*, the Supreme Court forced a school district to reinstate a ninth-grade cheerleader to the junior varsity squad after it disciplined her for cursing the school on her Snapchat story. This decision left schools to grapple with the difficult questions of when they may regulate student speech, whether it is on campus, off campus, or on social media. This panel will address the complex problems inherent in balancing students' First Amendment rights in on-line speech against a school district's mission to educate students, curtail cyberbullying, and prevent disruption of the educational environment in the wake of *Mahanoy*. It will explore challenges faced by school officials with limited resources and access for investigating on-line conduct, litigation faced by schools for failing to curtail on-line bullying, and the damages that may flow from student discipline, including missed scholarship opportunities and impacts on college admissions.

The US Supreme Court in 2024 issued many opinions that will have lasting importance for FDCC members and their clients. This panel will discuss several of the most significant cases. ## American Mother: A Story of Grace, Humanity, and Radical Empathy in the Practice of Law

Our invited keynote speakers are Diane Foley, Colum McCann, and Dennis Fitzpatrick. Ms. Foley is the President of the James Foley Foundation, the subject of Mr. McCann's recent best-selling book *American Mother*, and Mr. Fitzpatrick is the former Assistant United States Attorney who prosecuted the case which is the subject of the book. *American Mother* is the heart-rending story of a mother, who in the course of confronting her son's killer after a federal court trial and conviction, comes to understand violence, understanding, forgiveness, and empathy. Diane Foley is the mother of James Foley, an American journalist kidnapped in Syria by ISIS terrorists in 2012 and murdered by those terrorists in 2014. Seven years later, 2021, Ms. Foley had the opportunity to confront the murderer of her son in an Alexandria, Virginia courthouse, thereafter inspiring her to tell her life and son's life story. McCann's book brings the reader along with Ms. Foley on her journey of strength, resilience, forgiveness, and empathy. FDCC member Jack Delany, a nationally recognized trial attorney, will moderate a discussion amongst Ms. Foley, Mr. McCann and Mr. Fitzpatrick explaining how a prepared, empathetic, and sincere defense trial attorney can best marshal the evidence and law to present a compelling case on behalf of his or her client, avoid the catastrophe of an adverse nuclear verdict, while perhaps fostering opportunities for a reasonable resolution. *American Mother* became a documentary film nominated for an Academy Award and the subject of a song composed by Sting. Real or radical empathy, not as a tactic or strategy, but as the reflection of genuine sincerity on the part of counsel, may minimize the risk of nuclear verdicts and promote reasonable case resolutions.

Tours and presentations at Middleton Place recognize our nation's complex history and focus on the contributions of the Middleton family as well as the enslaved Africans and African Americans who lived and worked there. The excursion includes craft demonstrations by the blacksmith, potter, basket weaver, quilters, and carpenters. Your admission includes a private house tour and access to the gardens and stable.





### **Pickleball Tournament**

Enjoy a fun afternoon of pickleball in a climate-controlled environment and a state-of-the-art facility at CrushYard in Charleston. Whether you are new to the "fastest growing sport in America," or are an avid dinker, come join the fun. ## On Your Own in Charleston

Charleston is filled with numerous historical sites, outdoor activities and other attractions. Here are some ideas, if you want to explore on your own.

### Aiken-Rhett House

[Historic Charleston Foundation - Aiken-Rhett House](#)

Charleston's historic Aiken-Rhett House offers a rare glimpse into antebellum plantation life in South Carolina. The only surviving urban plantation house, the 1818 townhouse complex and its furnishings remain largely intact.

### The Battery and White Point Garden

The Battery wraps around the edge of Charleston's peninsula, providing an elegant buffer between the city and the Ashley and Cooper rivers. Stroll and sightsee along the wide pedestrian paths, which pass by antebellum homes, historic sights, and beautiful live oaks in White Point Garden.

### Charleston City Market

Located a short walk from our hotel, the Charleston City Market is a central landmark for Holy City visitors. In addition to being one of the most visited historic attractions in town, the City Market—opened in 1807—is also one of the oldest continuously operating public markets in the US.



### The Charleston Museum

Established just prior to the Revolutionary War, the Charleston Museum focuses on the natural and cultural history of the South Carolina Lowcountry.

### CSS Hunley – Civil War Submarine

See the Confederate submarine, CSS Hunley, which conducted the first successful combat mission by a submarine, sinking the USS Housatonic in Charleston Harbor in 1864. The Hunley disappeared under the waves for more than 130 years, but was recovered in 2000, and is now being studied and preserved.
