A refund, less any applicable credit card fees, will be given if the FDCC Executive Director receives written notice no later than **January 22, 2026.**

A full refund of all registration fees, less \$250, will be made if the notice of cancellation is received by the Executive Director on or after January 23, 2026 but before February 13, 2026.

A refund of all registration fees less \$500 will be made if the notice of cancellation is received by the Executive Director on or after February 13, 2026.

Activity charges may be refunded if the Vendor refunds fees or if another member fills and pays for the spot vacated by the cancellation.
