A refund, less any applicable credit card fees, will be given if the FDCC Executive Director receives written notice no later than **January 22, 2026**.

A full refund of all registration fees, less \$250, will be made if the notice of cancellation is received by the Executive Director on or after January 23, 2026 but before February 13, 2026.

A refund of all registration fees less \$500 will be made if the notice of cancellation is received by the Executive Director on or after February 13, 2026.
