#3 Multiple Claimants and Limited Coverage Available:

Is it a New Day in Florida?

There is perhaps a no more vexing conundrum for trial lawyers and insurers than the task of addressing claims where

there is limited insurance coverage and multiple claimants from a single covered incident - the "multiple claimant scenario". That is especially true in the great State of Florida, where liberal juries and plaintiff-friendly venues are abundant. Traditionally in Florida, liability insurers had been faced with a "no-win" scenario and almost certain bad faith claims arising from these unfortunate situations.

Without the benefit of any meaningful legislation or statutory guidance, case law developed which required defense lawyers and insurers to accomplish the herculean task of identifying and evaluating all potential claimants and then attempting to somehow resolve these known claims to the satisfaction and protection of their insureds and clients. To seek out and identify all claimants, often with inaccurate and incomplete police crash reports, insurers and their counsel had to nevertheless pursue avenues of investigation with the hoped for cooperation of claimants, witnesses and their insureds/clients, with the goal ultimately of having an informal settlement conference,

mediation or old-fashioned one by one negotiation. All in an effort to globally resolve all of the known claims. Without question, this amounted to the proverbial "herding of cats" with an uncertain fate to be sure.

Fortunately, though, in 2023, and for perhaps the first time (or at least in recent memory...), the Florida Legislature rose to the occasion and enacted meaningful tort and bad faith reform legislation to protect for insurers. Specifically, in 2023 significant revisions to FS § 624.155 were enacted which not only codified certain bad faith standards but also provided a safe harbor period for an insurer to tender its policy limits. More germane to this article, the legislation provided insurers with a framework for dealing with the multiple claimant scenario.


