

#2 Do You Want A Therapist or a Coach? Mediator Neutrality v. Evaluative Approaches in Mediation By: Eric Gillett



There are times when the last thing we want to hear is an unsolicited opinion. It is no surprise that one of the things we are taught at a young age is to keep our opinions to ourselves. I know that this operates more in the breach than the observance, so it strikes me as appropriate to look at how this impacts our approach to mediation.

I recall a mediation years ago where I very much wanted the mediator's opinion about my case. For one reason, I was working in a legal area where I had very little experience, certainly much less than the attorney on the other side. It was a maritime case and the plaintiff's lawyer was a maritime attorney. So, when he would wax eloquent on the vagaries of some ancient mariner case, I was wondered whether I had all the tools I needed to protect my client. Therefore, when it came to the mediation, and our mediator also had a deep background in maritime cases, I leaned on him as a soundboard for my defenses. It turns out I had it mostly right and my defenses held water. That gave me great comfort when the case didn't settle, and we ended up in trial. And even better when the jury returned a defense verdict.

The FDCC 2026 Annual Meeting





#5 Managing Wage Loss Claims in Personal Injury Cases: PART 1: Identifying Measurable Disruption & Baseline Wages

This will be a 3-part series on how to manage wage loss claims. Increasingly, alongside the rapid growth in the prevalence and magnitude of life care plans (“LCPs”), we are seeing larger and more prevalent wage loss claims. It would not be surprising if, in some personal injury cases, dubious wage loss claims were included simply to add credence to the assertions of the outsized LCP. In this 3-part series, we will discuss, from an economic damages perspective, 6 critical questions:

Part 1: (1) Was there a measurable disruption or impact on the ability of the person to work? If so, can the impact be measured as a percentage of disruption and duration of disruption? And (2) What is the true “earnings capacity” of the

individual, and what evidentiary data is available to confirm earnings capacity? This includes earnings capacity associated with changes in occupation.

In Part 2, we will focus on (3) What is the expected growth rate in earnings? In addition, (4) what is an appropriate “discount rate” for the value of future earnings?

Finally, Part 3 will focus on: (5) What is the work life expectancy (“WLE”) of the individual? A related question (6) is what is the expected work “productivity” of the individual? Individuals earning hourly wages may, due to pre-existing conditions, have lower work productivity compared to their peers without pre-existing conditions.

Part 1: Measurable Disruption & Earnings Capacity

Setting aside for a moment issues of liability and attribution, it is important to verify that a work disruption has indeed occurred, and the magnitude of the impact; that is, ranging from 0% for no discernable impact to 100% for inability to work.
