#5.1 Member in the Spotlight: Tom Bazemore



This week, we are shining the Federation's spotlight on Defense Counsel Member, [Tom Bazemore](#), a Partner at the [Huie Law Firm](#) in Birmingham, AL. In conjunction with his colleagues from the firm, Tom secured a defense verdict on behalf of Allstate Insurance Company following a week-long jury trial in the Northern District of Alabama, Jasper Division.

The lawsuit arose from damages to Plaintiff's residence following a storm, and in which they asserted claims for breach of contract and bad faith seeking damages in excess of \$3 million. Plaintiffs claimed that the storm and a tree striking their residence also caused damage to the foundation. Tom and his trial team asserted that the claim had been fully and

reasonably adjusted and more than adequately paid. Additionally, engineers and a forensic accountant had been produced to establish the nature of the damage to the property and adequacy of payment. They were also able to prove that Plaintiffs materially misrepresented their claim to the insurance company.

Congratulations Tom on an exceptional outcome.


