## **#4 The End of "Woke" AI? Navigating Executive order 14319 in Federal Procurement**

On July 23, 2025, the President of the United States published an executive order titled “Preventing Woke AI in the Federal Government.” This order follows the ongoing efforts to erase all “diversity, equity and inclusion” initiatives, describing DEI as one of the most destructive “ideological biases or social agendas” and “ideological dogmas.” A brief summary of the key provisions of the order is below along with dos and don’ts for federal agencies and vendors procuring services for the federal government.

### **Executive Order 14319 in a Nutshell**

The order applies to every executive-branch agency and any “wholly owned Government corporation” as defined in section two of the order. Section 3

provides that those agencies may only procure large language models (LLMs) that must satisfy two “unbiased AI principles.”

- *Truth-Seeking* – prioritizing historical accuracy, scientific inquiry, objectivity, and candor about uncertainty.
- *Ideological Neutrality* – prohibiting models that “encode partisan or ideological judgments,” specifically singling out concepts associated with DEI, critical race theory, intersectionality, etc.
